### Global Design Collaboration and Limited Editions

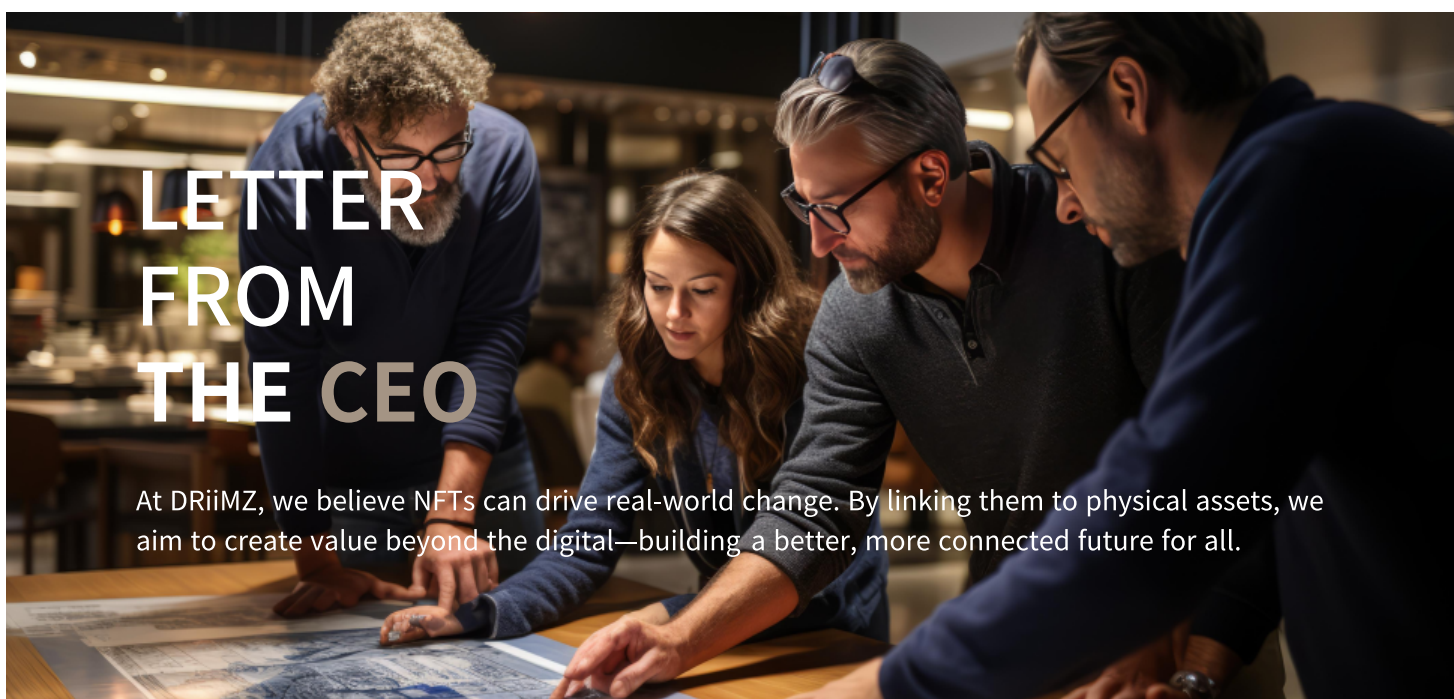

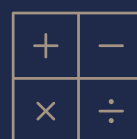
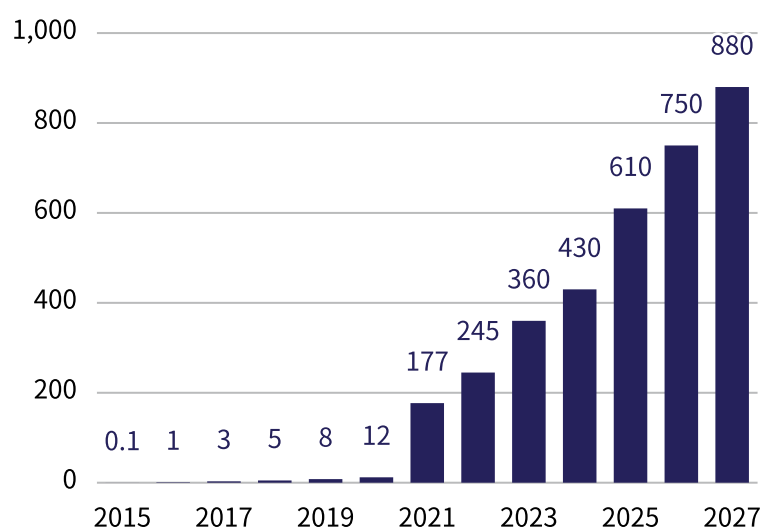
DRiiMZ was created to address this gap by redefining the NFT experience through three core solutions:

## DRiiMZ: A Real-World Utility NFT Collection Bridging Art, Experience, and Impact

DRiiMZ is a real-world utility-based NFT collection that integrates physical prize draws, charitable giving, and globally curated designer artwork. Each of the 12,000 unique NFTs is issued with its own distinct design, and automatically includes one entry into a physical reward event. Buyers can easily purchase NFTs via credit card on the DRiiMZ platform, and securely store their assets in a user-friendly custodial wallet—no blockchain knowledge required.

With DRiiMZ, collecting an NFT marks the beginning of an experience—not the end. Collaborating with top global designers, the collection delivers exceptional artistic value, while the randomized real-world reward system bridges the gap between digital ownership and tangible benefit.

For example, NFT holders are entered into raffles where they may receive physical fashion items, exclusive invitations, or limited-edition merchandise. This fosters a sense of anticipation and encourages community engagement throughout the process.

Additionally, a portion of all proceeds from DRiiMZ NFT sales is automatically donated to international child support organizations. Each NFT carries a record of this donation history, embedding social impact into the asset itself. Through this model, DRiiMZ offers a new kind of NFT culture—one that unites collecting, experiencing, and giving into a single, meaningful act.

To ensure fairness and transparency, each event operates using a pre-assigned ticket number system, governed by a randomized blockchain algorithm.

Beyond physical engagement, every DRiiMZ NFT is directly tied to a charitable donation system aimed at supporting children worldwide. This transforms NFT ownership into a purpose-driven act, blending individual value with collective benefit. Each donation is recorded immutably on-chain, offering verifiable proof of contribution and long-term social influence.

Collectors receive their NFTs through a custodial wallet provided by the DRiiMZ platform, with full flexibility to transfer them to any external Web3 wallet. Select NFTs also grant priority access to exclusive limited-edition product drops and VIP events hosted by DRiiMZ's partner brands and creators. Through this unique utility ecosystem, DRiiMZ evolves into a participatory NFT platform that fuses digital culture, social responsibility, and premium lifestyle experiences—setting a new standard for real-world connected NFTs.

## Technology Stack : Comprehensive Analysis

At DRiiMZ, we've developed a custom technology stack designed to make NFT ownership as intuitive, accessible, and secure as possible. Our platform bridges the gap between digital assets and real-world interaction through the following core technologies:

### **Custodial Wallet System**

Users can create an NFT wallet instantly with just an email—no complicated Web3 wallet setup required. The custodial wallet is fully integrated with DRiiMZ's backend, securely storing NFTs while allowing seamless transfers to external wallets when desired.

### **Proprietary Minting Engine**

Our minting infrastructure is built on an Ethereum-compatible blockchain, ensuring both scalability and security. The one-click minting process within the DRiiMZ platform is optimized for ease of use, with Layer 2 integration in development to reduce gas fees and enhance speed.

### **Credit Card Payment Integration**

Through partnerships with global payment gateways such as Lamport and Stripe, users can purchase NFTs directly using their credit or debit cards—no need for cryptocurrency. Upon successful payment, NFTs are automatically transferred to the user's wallet.

### **Blockchain-Based Raffle System**

All physical reward raffles are conducted via smart contracts on the blockchain. Each raffle entry and result is publicly verifiable on-chain, offering a transparent and tamper-proof process that builds trust and ensures fairness for all participants.

### **Donation Tracking Smart Contracts**

# Custodial Wallet System

DRiiMZ leverages Crossmint's wallet infrastructure to provide a seamless custodial wallet experience. Unlike traditional Web3 wallets, Crossmint wallets require no external software installation or seed phrase management, enabling instant wallet creation with just an email.

### Key Features

- **No Software Installation:** Users can create and use wallets without downloading any programs or extensions.
- **Email-Based Authentication:** Simplifies access for non-crypto-native users, eliminating the need for private key management.
- **Crossmint Integration:** Wallets are fully managed through Crossmint's API, ensuring scalability and security.

### Technical Architecture

Crossmint wallets operate on a custodial model where private keys are securely stored on Crossmint's backend infrastructure. This system uses advanced encryption protocols (AES-256) and hardware security modules (HSM) for key management. The wallet architecture supports:

The integration of Crossmint wallets eliminates onboarding barriers, allowing users to interact with NFTs without prior blockchain knowledge. This approach aligns with studies showing improved adoption rates when Web2-like interfaces are used.

# Road Map

DRiIMZ is building a platform that transcends traditional NFTs by focusing on real-world value and social impact. Our roadmap outlines key phases, starting with design partnerships and platform development in late 2024, followed by the platform launch and initial NFT collection in early 2025. Subsequent phases in mid-2025 will concentrate on global marketing and community growth, leading to a second collection and Web3 feature integration in late 2025. Our long-term vision beyond 2026 involves expanding brand collaborations, real-world rewards, and evolving into a sustainable social impact platform powered by NFTs.

DRiIMZ's roadmap outlines a phased NFT ecosystem build focusing on real-world value and social impact. Late 2024: project design finalized, 30+ designer partnerships secured, credit card purchase system design, wallet/minting infrastructure development begins. Early 2025: platform launch, initial 4,000 NFT collection release, real-world events with exclusive merchandise, charitable partnerships, smart contract registration. April-June 2025: global marketing, influencer collaborations, community growth via online/offline exhibitions, European/Southeast Asian market entry prep. H2 2025: second 8,000 NFT collection, metaverse integration, in-platform marketplace, AR feature for physical-digital linking planned. Post-2026: global expansion via brand collaborations, diversified rewards, joint charity projects, evolving into a sustainable 'Social Impact Platform'.

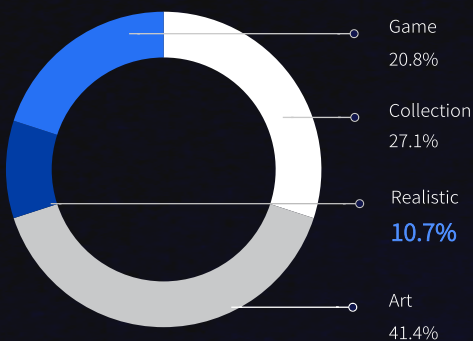

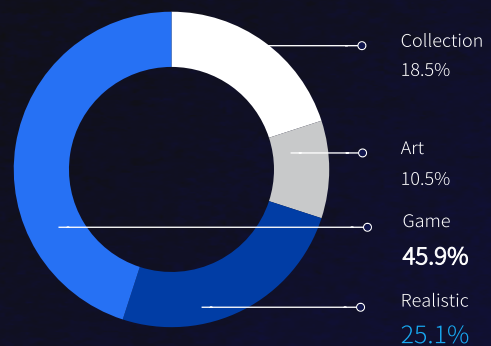
### Market share

2025 NFT Market share



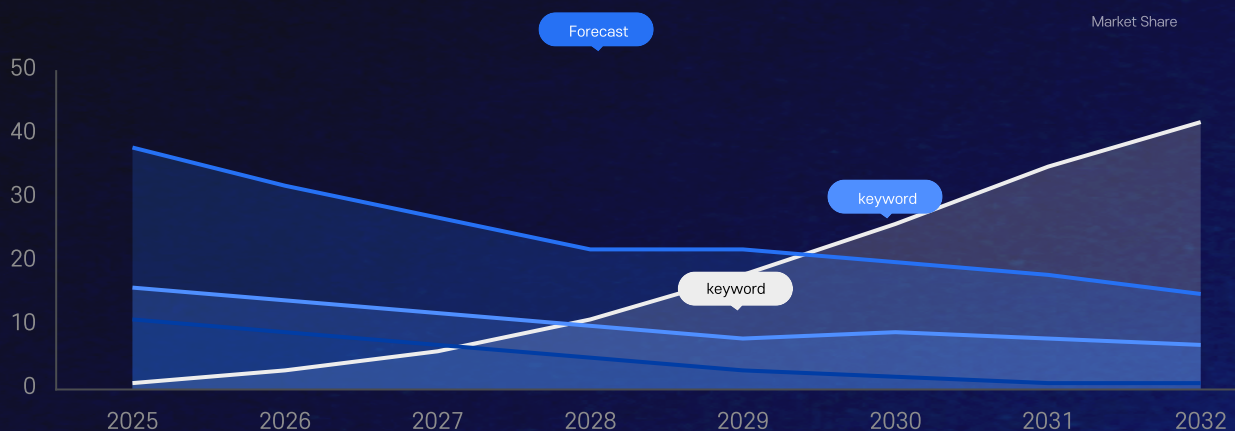
Collectible and art-based NFTs currently account for more than half of the market, reflecting strong interest in digital ownership and creative expression.

Over the next decade, demand for NFTs integrated with real-world utility is anticipated to rise significantly, fueled by growing interest in tangible value and practical applications.

NFT Market Share: The projection indicates a significant growth in the Gaming & Metaverse NFT sector by 2035. Conversely, the market share of Digital Art and Collectible NFTs is expected to decrease. The "Other" category, encompassing music, tickets, and more, is predicted to see a moderate increase due to expanding use cases.

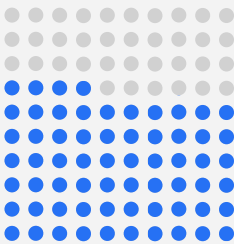

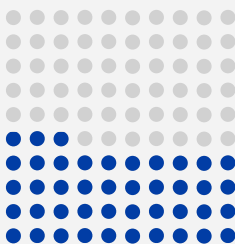
##### Decision-Making Structure

All major decisions regarding the platform (NFTs, events, donations, blockchain initiatives) are made by the DRiiMZ operations team after gathering and considering feedback from our user community.



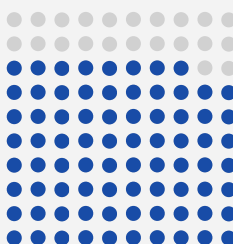

##### Credit Mechanism

We operate on the principle of 1 NFT = 1 Credit. These credits serve as access passes to exclusive events and experiences within our ecosystem.



##### Credit System

Each NFT purchase automatically grants 1 credit to the buyer through a 1:1 airdrop ratio.

Utility: Credits function as event participation passes, providing NFT owners with exclusive experiences unavailable to non-holders.

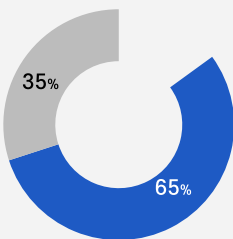
##### Air Drop

Credits are automatically airdropped to the buyer's wallet at the time of NFT purchase.

Characteristics: Credits operate as an internal utility system within the project and are not tokens or cryptocurrency assets.

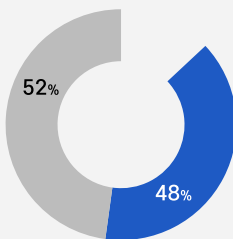
##### Community Fund

Sustained ecosystem via revenue allocation: platform refinement, active engagement incentives, and 1% UNESCO donation for global impact.



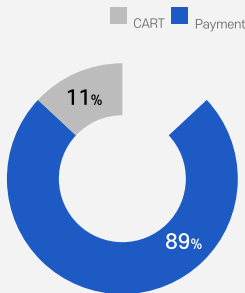

Virtual Asset Service Provider Status: We do not operate as a virtual asset service provider. Our operations are based on legal interpretations that NFT issuers are not required to register as virtual asset service providers.
